## TERMS AND CONDITIONS

### 1. MAKING RESERVATIONS

- Reservations are made via email: [camping.split@gmail.com](mailto:camping.split@gmail.com) or the Enquiry form on our website; <https://www.campingsplit.com/reservations>
- Upon receipt of the request, the Campsite makes a temporary reservation that is valid for number of days marked in our offer (the number of days may vary depending on the date of arrival).
- After we receive your confirmation, we are sending you data for deposit payment and it is **30 percent** of the reservation value.
- Camping pitch reservation contains a fixed cost of the **Reservation fee** in the amount of **185 HRK**. Indicated amount is **not refundable** and it will **not be deducted** from your Final receipt. Our **CANCELTION TERMS are available on the page number 2. and 3.** under the title 5: "RESERVATION CANCELTION, LATE ARRIVAL AND EARLIER DEPARTURE."
- Your accommodation costs at our Campsite are going to be reduced by the amount of the deposit you have paid. The total bill must be paid at the Reception desk.
- The minimum advance deposit for lower value reservations is EUR 50.00
- The deposit can be paid via bank transfer.
- To make your reservation valid/final, the deposit has to be paid within number of days marked in our offer. If the deposit has not been paid in a timely manner, the reservation will be invalid. The reservation will be automatically cancelled if no notice of the deposit is received.
- After the deposit has been paid, an e-mail notification is required in order to confirm the reservation.

### 2. DIFFERENCE IN THE AMOUNT OF THE OFFER AND THE BILL ISSUED AT THE RECEPTION DESK

### 3. RESERVATION CONFIRMATION

1. On the receipt of the deposit, the guest will be sent a reservation confirmation to the e-mail address that has been provided.
2. A copy of the reservation confirmation must be enclosed when checking in at the reception desk. The reserved dates will be specified in the confirmation letter.

### 4. RESERVATION CHANGE

1. Reservations can be changed not later than one month prior to the date of arrival, depending on the availability (of time period or accommodation unit).
2. If a different number of guests will be staying on a pitch than specified when making a reservation, only guests who have actually arrived will pay for their stay according to the applicable price list.
3. If a different number of guests will be staying in a mobile home or a bungalow, only tourist tax and registration fee will be charged to the guests staying in a mobile home/bungalow.

### 5. RESERVATION CANCELLATION, LATE ARRIVAL AND EARLIER DEPARTURE

1. Reservations may be cancelled only in writing. We do not accept cancellation requests by phone.
2. In case of unannounced late arrival, your reservation will be held until 13:00 o'clock the next day. After that it can be offered to another guest.
3. In case of late arrival the guest will be charged the full reserved period.
4. In case of early departure, the reservation of a Mobile Home will be charged for the whole booked period.

5. If cancellation has been made at least 45 days before the arranged arrival date, total amount of deposit payment will be reduced for transaction costs in amount of 150,00HRK and reservation fee cost in the amount of 185,00HRK - only for Camping pitch cancelations. **The rest of deposit payment will be refunded by converting the rest of the amount from HRK to EUR using middle exchange rate of "Croatian National Bank" [www.hnb.hr](http://www.hnb.hr)**
6. If cancellation has been made at least 29 days before arrival, 50% of deposit payment will be reduced for the transaction costs in the amount of 150,00HRK and reservation fee cost of 185,00HRK - only for Camping pitch cancelations. **The rest of deposit payment will be refunded by converting the rest of the amount from HRK to EUR using middle exchange rate of "Croatian National Bank" [www.hnb.hr](http://www.hnb.hr)**

## 6. RESERVATION OF A SPECIFIC ACCOMMODATION UNIT

### 1. PITCHES

1. There are various types of pitches in different camping zones, and the campsite will do its best to ensure that the selected pitch suits the RV/trailer/tent, same as amenities listed in the Enquiry Form or direct mail.
2. Our booking agent assigns the pitch number and the guest will be informed of that number on arrival at the Campsite. Preferences will be taken into consideration whenever possible, depending on the availability.

### 2. MOBILE HOMES/BUNGALOWS

1. In a high season Mobile Home reservations can only be made from **Saturday to Saturday**. This rule is not applying on Mobile Home 12m2 and Bungalow reservations.
2. Our booking agent assigns the mobile home/bungalow number and the guest will be informed of that number on arrival at the Campsite, except if reservation was made for a special type of Mobile Home for example VISTA – first row, Sea view.

3. Bed linen and 1 small towel per person are included in the mobile home price and are changed once a week depending on the day of arrival.
4. Cleaning on departure is not included in the mobile home price. Cost for Final cleaning is 225,00 kuna.

## 7. CHECK-IN AND CHECK-OUT

Personal data is also collected and processed on arrival at our Reception during check-in process. We must enter your personal data into a reception business program.

In case you do not provide us with your personal document and data during registration, your stay at Camping Stobreč Split is not possible.

Entering personal data into a reception business program and sending them via E-system to the relevant Tourist Association, is company's Legal obligation and it is in accordance with the General Data Protection Regulation and with the Tourists Register Regulation.

### 1. Mobile homes/bungalows:

- check-in on arrival date is from 16:00
- check-out on departure date is from 07:00 to 10:00

### 2. Pitches:

- check-in on arrival date is from 13:00
- check-out on departure date 07:00-12:30

For late check-out additional fee will be calculated or an extra night will be charged, depend on the time of departure.

## 8. PAYMENT

1. In order to avoid any delays or waiting in line, we recommend you to settle your account a few days prior to the departure date.
2. One-time payment can be made using bank card Visa, Maestro and MasterCard and by cash payment in Croatian Kuna only.
3. Payments cannot be made in any other currency. Currency exchange services are offered at the reception desk.

## 9. PETS

1. Camping Stobreč Split is a pet-friendly campsite.

3. Two dogs are allowed per one renting unit.
4. In the campsite area, including its food service establishments, pets must be kept on a leash.

### 10.1. Mobile homes/bungalows

Pets are allowed in mobile homes and bungalows and subject to a special pet charge different from the ones applicable to campsite pitches. **Owners are obliged to bring a special bed or a cover for their pet to protect the furniture in the accommodation unit.** In case of any damage, the owner will be liable for damages and additional cleaning charge.

### 10.2. Pitches
